## YOUTH TEAM QUALIFICATIONS:

- 1. **GIRL'S DIVISIONS:** (Determined by school grade as of September 2017)  $3^{rd}$  through  $12^{th}$  grade
- 2. **BOY'S DIVISONS:** (Determined by school grade as of September 2017) 3<sup>rd</sup> through 12<sup>th</sup> grade
- 3. Tournament Committee reserves the right to move teams to higher or lower divisions.
- 4. Rosters should be limited to 10 players as only 10 awards will be given for Championship, Second, Third (For 8 team divisions) and Consolation. Teams with more than 10 players will not be excluded.
- 5. Each team is responsible for providing their own insurance coverage and will be required to sign a waiver.
- 6. Each team must have uniforms with numbers on the front and back and have a spotter available for each game.
- 7. Team rosters are limited to league rostered players who have signed the team waiver form prior to the first game. Non-league rostered player requests must be submitted in writing to Tournament Committee for approval at least **4 weeks** prior to the tournament. Any protest regarding eligibility of player must be made prior to the first game. Tournament Committee has final ruling on player eligibility and/or acceptance.
- 8. All tournament roster changes approved from September 1<sup>st</sup> 30<sup>th</sup> will be subject to a \$25 per player roster change fee. The deadline for all roster changes is October 1<sup>st</sup>. Any roster changes between October 1<sup>st</sup> and 6<sup>th</sup> will be subject to a \$50 player change fee. No roster additions after October 6<sup>th</sup>, 2016 will be accepted except for extenuating circumstances.
- 9. It may be necessary to schedule concurrent games in some of the larger gym facilities.
- 10. SEYO, CBO, CYC & JAO rules will govern player eligibility.
- 11. Special hotel accommodations will be made available to tournament participants however each team is responsible for the conduct of each of its players and families.

ENTRY FEE: Payable to the VFW Post 3670 Youth Group, must accompany team roster. - \$400.00 PER TEAM (BOYS & GIRLS TEAMS 3<sup>RD</sup> THROUGH 12<sup>TH</sup> GRADES) DEADLINE IS JULY 8, 2017.
